The IIA Ghana was formally registered in Ghana in April 2001 in accordance with the Professional Bodies Registration Decree, 1973 (NRCD 143) as a professional association dedicated to the promotion and development of the practice of intenal auditing in Ghana.

The Institute was formally inaugurated on 13 May 2005 by the then Hon. Minister of Finance & Economic Planning on behalf of His Excellency the President of the Republic of Ghana.

The Institute is a fully-fledged member institute of the Global Internal Audit family. The IIA Ghana is also a founding member of AFIIA and has had its members serving on the AFIIA Governing Council. The IIA Ghana also actively pursues collaboration and partnership with sister national institutes, particularly the African institutes.

### GOVERNANCE STRUCTURE

The IIA Ghana is governed by an eight-member Governing Council (The Council). The President, the Vice-President and five (5) other members are elected by members at an Annual General Meeting (AGM) for a two-year term. The Immediate Past President is an ex-officio member.

The Council is also supported by five working committees: Finance, Advocacy & Regulatory Compliance, Certification & Professional Development, Research & Publications and Chapter & Sector Relations. The Ethics & Standards committee operates as an ad hoc committee. The Council also works through other ad hoc committees as and when required. A team of staff at the Secretariat, led by the Chief Executive Officer (CEO) assists the Council to execute its mandate.

# **IIA Ghana Hosts Contemporary Cyber Security Essentials Training** at Sunlodge Hotel

In a concerted effort to equip internal audit practitioners and other professionals with innovative cyber-security skills, the Institute of Internal Auditors (IIA) Ghana successfully held its "Contemporary Cyber Security Essentials Training" from 25 to 27 March 2024. The training session, which took place at the Sunlodge Hotel in Tesano, Accra, attracted an impressive 76 participants.

This vital training followed the approval of the Institute's 2024 training calendar by the IIA Council on 29th February 2024. In line with the calendar, the Certification and Professional Development Committee developed comprehensive terms of reference, inviting facilitators to present their proposals. The E-crime Bureau, a long-standing partner of the Institute, was selected as the training provider, recognised for their proven track record and competitive pricing.

The training targeted a diverse audience, including internal audit practitioners and non-auditors with an interest in cyber security. For the internal auditors in attendance, the programme focused on crucial topics such as understanding emerging cyber-security threats, detecting fraudulent financial activities using digital forensics, and planning risk-based cyber-security engagements. Participants were also guided on how to effectively monitor and evaluate cyber-security controls within their organisations.

In addition, non-audit professionals benefited from training that emphasised cyber-security risk assessment, control implementation, and the prevention, detection, and correction of fraud. These broad themes ensured that participants left with a well-rounded understanding of how cyber security intersects with their various professional roles.

The programme covered a wide range of key areas, including Cyber Security from an Internal Audit Perspective, Components of Cyber Security, Cyber Security Standards, Laws and Regulations, and Risk Assessment, among others. This comprehensive scope ensured that both new and seasoned practitioners gained insights into the dynamic field of cyber security.

Speaking at the closing session, the President of the Institute Mr. Joseph Dakora Zumasigee noted, "The training has been an excellent platform to not only build our members' capacity in cyber-security assurance but also to foster collaboration across different sectors. In today's world, where cyber threats are ever evolving, it is essential that internal auditors stay ahead of the curve."

Participants expressed their satisfaction with the training, lauding the facilitators from the E-crime Bureau for their depth of knowledge and practical approach to delivering complex content. The venue, Sunlodge Hotel, was also praised for its competitive pricing and flexibility, contributing to the success of the event.

# Internal Audit Month Awareness Walk

# 2024 IIA Ghana Annual National Internal Audit & Governance Conference

The Institute of Internal Auditors (IIA) Ghana successfully hosted its highly anticipated Annual National Internal Audit and Governance Conference from 8 to 10 May 2024 under the theme "Beyond Boundaries: Navigating New Frontiers". This year's event brought together 410 participants, including heads of institutions, chief executive officers, senior management, internal auditors, and professionals from diverse sectors. The three-day conference, held at the University of Professional Studies, Accra (UPSA) Auditorium, delivered impactful discussions on trends, challenges, and advancements within the internal audit profession.

### **Opening Ceremony and Keynote Address**

In his presentation on AI capabilities and their impact on the internal audit profession, Mr. Divine Teyi, Group CEO of IS Evolutions Consult Limited, demonstrated how Al is reshaping audit practices, encouraging internal auditors to adopt new methodologies that enhance efficiency and accuracy in their work. Another pivotal session was led by Dr. Eric Oduro Osae, focusing on the changing terrain of public sector internal auditing, which sparked a thought-provoking discussion on the future of governance frameworks in Ghana.



The session featured an expert presentation by Mr. Samuel Reuben Ofori, a highly qualified professional with designations including Certified Internal Auditor (CIA), Certification in Risk Management Assurance (CRMA), Fellow of the Association of Chartered Certified Accountants (FCCA), Certified Information Systems Auditor (CISA), and ISO 27001 Lead Auditor.

The webinar attracted a remarkable participation of 321 individuals, showcasing keen interest in enhancing knowledge and skills regarding the governance of internal audit functions. Mr. Ofori's expertise guided participants through the key aspects of Domain III of the GIAS, which is crucial for establishing a robust internal audit framework.

3-Day Training Workshop: Tools for Auditing Fraud Risk Management Processes

The Institute of Internal Auditors (IIA) Ghana successfully organised a 3-day intensive training workshop aimed at enhancing the competencies of internal auditors and other assurance providers in managing fraud risks, with a particular focus on procurement fraud. Held from 24 to 26 September 2024, the workshop took place at the Sunlodge Hotel at Tesano, Accra, attracting 103 participants from diverse professional backgrounds.

The training topic, "Tools for Auditing Fraud Risk Management Processes," underscored the need for professionals to be equipped with the necessary knowledge and tools to effectively govern and manage fraud risks within their organisations. The facilitators, Mr. Abraham Ablorh Mensah and Mr. Andrew Kwadwo Baafi, expertly guided the participants through various topics, offering insights into fraud risk management and governance, and providing practical skills for evaluating fraud controls, particularly in the procurement cycle.

The target audience for the workshop included internal audit practitioners, assurance service providers in risk management, internal controls, compliance professionals, and other experts with an interest in fraud risk management. The training objectives centred on empowering participants to execute their fraud risk management responsibilities with greater efficiency and precision.



# 3-Day Training Workshop: Tools for Auditing Fraud Risk Management Processes

- An in-depth understanding of fraud risk management.
- The ability to differentiate between governance and management roles in fraud risk.
- Skills to evaluate the adequacy and effectiveness of fraud risk management controls, covering preventive, directive, detective, and corrective measures.
- Expertise in assessing procurement fraud management controls.
- Incorporating fraud risks into audit work programmes

#### For Other Assurance Providers and Professionals:

- Comprehensive knowledge of fraud risk management and its governance.
- Skills to design and assess the adequacy of fraud risk management controls, particularly in the context of procurement.
- Guidance on implementing and evaluating procurement fraud management controls.

### Scope of the Programme:

The training covered a wide range of topics, including:

- Types of fraud and risk exposures, including the Fraud Triangle.
- The impact of fraud on stakeholders.
- Fraud Risk Governance and Management Roles, as outlined in IIA's Three Lines Model.
- Tools for fraud risk assessment and management.
- Procurement fraud risk identification, assessment, and management.
- Legal considerations and implications of information systems in procurement fraud management.
- Techniques for integrating fraud risks into audit work programmes and reporting fraud risks.

Participants left the workshop well-equipped with the knowledge and practical skills necessary to strengthen fraud risk management processes within their organisations, particularly in procurement, a high-risk area for fraud exposure. The facilitators received commendations for their expertise and interactive approach, which enabled participants to apply the learning in real-world scenarios.

The 3-day workshop was yet another testament to IIA Ghana's commitment to building capacity and fostering excellence within the internal audit profession and the broader assurance community.
